Sexual abuse lawsuit filed against Los Banos Unified School District, Merced County Office of Education

Corsiglia, McMahon & Allard law firm claims two alleged victims of former Los Banos teachers Gary Bettencourt and Dusty Norris seek to hold the enablers of their predators accountable for their sexual abuse.

Bettencourt currently serving an eight-year, four-month sentence; Norris' case is pending

Los Banos, CA - On July 21, 2022, the law firm of Corsiglia, McMahon & Allard filed a sexual abuse lawsuit in Merced County Superior Court alleging that former Los Banos High School teachers, Gary Bettencourt and Dusty Norris, sexually abused two young students. (please place complaint, here)

Identified as Jane Doe 1 in the lawsuit, the complaint alleges that Norris abused her during the 2004-2005 school year. At the time Norris was employed

by the Merced County of Education (MCOE) as an Regional Occupational Program (ROP) teacher at Los Banos High School. He is also a former Los Banos Police Officer.

The lawsuit also identifies Jane Doe 2 as a victim of both Norris and Bettencourt. Norris is still awaiting trial on charges that he allegedly sexually abused Jane Doe 1 and Jane Doe 2 while he was an ROP instructor. The abuse occurred with touching of Jane Doe 1 in class, and while driving her to job sites.

Former Los Banos and Pacheco High School drama and English teacher Bettencourt entered a no contest plea in 2016 to sexually abusing Jane Doe 2 along with two other students. He was sentenced to eight years, four months in prison.

Los Banos Mayor Tom Faria will not run for re-election, this year. According to

the list of candidates dated August 12. 2022, at 5:41 p.m. on the Merced County Elections office website (see page 12), he did not pull or file has now been extended by five calendar days until next Wednesday, August 17 at 5:00 p.m.

When reached for comment about the race Llanez said, "I'm just gearing up for campaign season. I don't know who my opponent will be. Either way I'm going to give it all I've got."

He is the president and CEO for a statewide company that provides emergency training, mainly active shooter training. A majority of their clients are school districts, he shared.

In addition, District 2 Councilman Refugio LLamas filed his papers on Friday and will face one challenger, teacher Doug Begonia (the son, not the father) who also filed, as previously reported.

"I still think I have things that I can contribute and things that still need to be done," he said when reached for comment on Thursday morning, Aug. 11.

The annual Los Banos Tomato Festival is the main annual event that celebrates the local tomato harvest. Tomatoes are a fruit that is one of the most famous local cash crops that gets exported to our

Abuse from p.1 School," attorney Lauren Cerri said. "That's where he and his girlfriend molested another victim for which they were convicted."

According to an ABC30 news report at the time of their arrest at their Turlock home on February 3, 2016, Bettencourt was 40 years old and his girlfriend, Devyn Egan was 22 years old.

"There are three victims of Bettencourt, one back in 2004. Then there's Jane Doe 2 who is a party to this lawsuit," Cerri explained. "There's a third, let's call her Jane Doe 3, who was the victim at Pacheco High. But she is not part of this lawsuit. He was convicted for all three." (See related article)

"Bettencourt should have never made it to Pacheco High School," the attorney stated. "Bells and whistles should have been going off. There were rumors that students knew about it. They knew or should have known that this guy shouldn't have been teaching high school students as far back as 2004."

In late 2017, attorneys for Jane Doe

1 and Jane Doe 2 withdrew a lawsuit against the Los Banos Unified School District due to an adverse California State Supreme Court ruling. The Court ruled that victims of sexual abuse prior to 2008, such as Doe 1 and 2, were required to provide school districts notice that they were going to file a lawsuit within six months of the date they were last abused.

The law was changed in 2020 with the passage of Assembly Bill 218. It did away with the claim requirement and allowed victims, no matter when they were abused, three years to bring a lawsuit. The three years expires Dec. 31, 2022.

"The 2017 Supreme Court ruling re-victimized a countless number of sexual abuse victims by holding young victims to an unjust six-month notice requirement," Cerri said. "Even though the state legislature immediately tried to clarify the law, school districts continued to enforce a six-month claim filing procedure until the passage of AB 218 explicitly eliminated all legal loopholes for claims against public institutions."

monetary damages.

"But the purpose of the lawsuit is to hold the government agencies accountable and protects future victims, so it doesn't happen, again," their attorney stated. "The school district failed these students and enabled these predators by turning a blind eye."

When Bettencourt was sentenced in 2016, attorney Robert Allard stated, "multiple warning signs or 'red flags' were presented but district employees either ignored them or were not sufficiently trained to identify them. It is only when this district is forced to accept full responsibility for its actions, or more appropriately inactions, that other school districts across our country will take the steps to ensure that this never happens again to another student."

"No hearing date for the lawsuit has been set. Following discovery, a trial will be set," Cerri explained.

Norris' criminal case for his alleged abuse of both Jane Doe's 1 and 2 is still pending and has an upcoming preliminary hearing.

When reached for comment LBUSD Superintendent Dr. Mark Marshall responded, "Los Banos Unified School District (LBUSD) is in receipt of a complaint alleging that former students were subjected to sexual abuse from 2005-2007 by a District employee and a school resource officer, employed by the Los Banos Police Department. The employee who worked for the District left District employment in 2016. The District is currently in the process of reviewing the

Incumbent City Clerk Lucy Mallonee was the only candidate to file in her race, but no one had yet to file to run for city treasurer as of Friday at 5:00 p.m. So, the filing deadline to run for that position was also extended by five days.

There was speculation whether or not Faria would seek re-election since he hadn't yet pulled papers and a for sale sign was seen in his yard on Thursday morning, August 11, 2022. Faria has yet to respond to questions if he is moving out of the city now that he retired from teaching, this year. In the Los Banos school board elections, three trustees, Gene Lieb in Area 1, Marlene Smith in Area 3 and Anthony Perreira in Area 5 face no challengers. But in Area 7, both incumbent trustee and current Board President Ray Martinez and challenger Dayna Valadao, a retired teacher, filed their nomination papers to run in time for Friday's deadline.

lawsuit, but due to the nature of the allegations, LBUSD is unable to provide any additional information at this time."

Merced County Superintendent of Schools, Dr. Steve Tietjen responded with, "The safety of our students and staff are our highest priority. Los Banos Unified School District and Merced County Office of Education have fully cooperated with the law enforcement investigation. As this is pending litigation, we have no further comment."

confusion about the filing deadlines and to whom they apply, and a belief expressed by some residents that Faria could still file during the extension period.

Mallonee was asked if incumbents had only until Friday at 5:00 p.m. to file and if they didn't file by then that's it for them and that the deadline is extended five more days only for other candidates to file by Wednesday, August 17 at 5:00 p.m. She directed this reporter to page 13 of the Merced County Candidate Handbook & Resource Guide.

There it reads: "If an incumbent, eligible to be elected, fails to file a Declaration of Candidacy by the close of business on the 88th day prior to Election Day, any person, other than the person who was the incumbent on the 88th day, may file a Declaration of Candidacy not later than the close of business on the 83rd day."

The 88th day prior to Election Day on November 8 was yesterday, Friday, Aug. 12. The 83rd day before the election is next Wednesday, Aug. 17.

So, that means neither Faria nor City Treasurer Kim Tomas can file during the extension period and seek re-election. Only other candidates for those positions can file by the August 17th deadline.

He truly loved to watch each of them grow up and was very proud to see the successful young adults they've all become. He was a friend to many, and quick to listen

to your story and step into your shoes. Ray was very proud of his family history and Basque Culture. He was heavily impacted by the stories of his parents' upbringing and their dedication to working hard and creating a family and life they were proud of. He carried that drive, grace and wisdom with him all his life. Ray was preceded in death by his mother and father, Elena Celayeta Talbott and Ramon Artadi Talbott; and his brother, James Artadi Talbott. He is survived by his wife of 57 years, Teresa (Terry) Irribarren

The Black Bear Diner (BBD) is a great and historical place to start our culinary journey in Los Banos since it has been a destination for decades of well-known diners at this same location, ranging from Sambos and Seasons up until the mid-eighties. Sacramento restauranteur Bob Rose, who was educated in accounting and business, helped guide the early growth of Sambo's restaurants in the mid-sixties. In the early seventies he was noticed and hired by Carrow's restaurants to grow their business from a few Santa Barbara area locations to about five hundred national restaurants. Finally in the late eighties he had an opportunity to start his own business with his wife Stella in the Central Valley and chose Los Banos, the geographic center of California, for his strategic initial location. The first all-day breakfast, lunch, and dinner-themed Ryan's Place, aptly named after his son Ryan, opened in 1986. I first frequented Ryan's Place upon moving to Los Banos from the Bay Area in 1989 for lower cost housing. I was astounded by the number and variety of the breakfast, lunch and dinner items on the menu. I had started commuting to

the Bay Area to my previous job and was always greeted by Bob or more usually Dave Alvarez when I arrived back in town after the long commute to join my wife and our new baby for early dinner, that was served almost any time after four in the afternoon at Ryan's. In those day's there was a mascot chef named Ry-Guy and a number of my favorite, immigrant inspired dishes on the menu like pork chops with Portuguese beans and linguica served by my favorite servers Anna Silva and Javier (Javi) Arriola.

There was also my favorite signature nutritional sandwich named the Pacheco Pass, to help the Bay Area commuters safely to and from the Bay Area on state route 152 so they wouldn't starve when there was an accident delay on the commute. Of particular note was when Bob was there, and at his table adjacent to the front door, there was usually his little daughter Amy with long braided pigtails, running around the restaurant with great energy. In 2012 Bob converted all of his multi-location and family-owned Ryan's restaurants to the Black Bear Diner format, a franchise that originally started in Mt. Shasta in Northern California in 1995. With Bob's help and strategic locations, BBD expanded into the Central Valley with his family-owned locations.

The Los Banos BBD was Bob's and Amy's favorite location and where Amy inspired the signature and healthy avocado toast breakfast dish with two eggs and fresh fruit. The BBD immediately became very popular with Bob's value-driven portions of fresh cooked-to-order food and no compromise on the quality or service. Local families lined-up to wait for a booth or a table along with commuters and travelers who stopped at this still-first and last stop in town for a delicious meal.

Fast-forward to today and you will still see Dave as manager, Javi, Tiffini and Adriana as loyal and experienced servers exhibiting the same energy as Amy does, along with the mascot Biscuit Bear and the more modern version of a Wurlitzer juke box belting out rock and roll favorites. Amy grew into her father's business and took over the seven or so remaining Ryan's and Black Bears and now is a very busy entrepreneur with a successful restaurant of her own.

And for adult 'bears' with smaller appetites, the 'little less' options will still ensure you don't go home a hungry bear along with the kid's menu also has great little bear options (I wish I could have!)

Los Banos residents can now receive cleaner electricity for less

All electricity customers in the city of Los Banos now have the choice to receive cleaner power at lower rates without having to sign up or install solar panels on their roofs. As of April, this year, Peninsula Clean Energy (PCE) began delivering greener electricity to Los Banos at a 5% savings compared to the electricity mix provided by PG&E.

Peninsula Clean Energy is a joint

powers authority comprised of the City of Los Banos and all 20 cities within San Mateo County. The governing board of 23 from the jurisdictions that all took action to join PCE includes one representative per city and two supervisors from San Mateo County

Peninsula Clean Energy, which has been the official electricity provider for San Mateo County since 2016, has already saved its customers there approximately \$104 million. At a time when PG&E has raised its electricity

rates across the state, the discount that customers will receive from the power generated by PCE could not have come at a better time.

In October 2020, the Los Banos City Council voted to join Peninsula Clean Energy to not just bring cleaner and less expensive electricity but also allow Los Banos residents and businesses to enjoy a wide range of rebates, incentives, and other programs to help customers save even more on electric appliances, electric vehicles and emergency backup power. Here's how it works:

Peninsula Clean Energy is a Community Choice Aggregation (CCA) public agency. As a CCA, PCE provides electricity generation, which is the source of your power. One source is the Wright 200-megawatt solar power project just southwest of Los Banos on Billy Wright Road. This local solar farm its rates for electricity delivery service, which all customers pay whether they belong to a CCA or not. The good news is that PCE customers' electricity generation rates are 5% less than if they purchased it from PG&E.

Energy customers don't need to do anything to become a PCE customer because enrollment is automatic. Starting in April, Los Banos customers were enrolled in PCE's default service plan, ECOplus. The average household enjoys a few dollars of savings on their monthly energy bill compared to what they would otherwise pay, while receiving cleaner power.

Customers also have the choice to opt out of PCE services and continue purchasing their electricity generation through PG&E. Enrollment notices were mailed out starting in February to all City of Los Banos customers explaining

PG&E continues to own and operate existing wires, poles and other infrastructure to deliver the power generated by Peninsula Clean Energy to participating homes and businesses. PG&E also still owns and reads electric meters and provides the same maintenance and other repair services they always have. And customers continue to receive their bills from PG&E and pay them in the same ways as before.

Customers with a special bill discount such as CARE, FERA, or Medical Baseline, don't need to worry - it remains in place. These customers also enjoy additional savings tied to Peninsula Clean Energy's discounted generation rates, which shows up as a separate line item on the PG&E bill.

Note that PG&E recently increased

v exclusively these new energy choices. ustomers. According to CEO Jan Pepper, PCE

is a not-for-profit public agency that reinvests their profits into the community. For example, two solar panel projects on Los Banos city facilities, the community center and the wastewater treatment plant, are planned. They will be free to the city and will provide the local government lower cost electricity, she shared.

PCE launched with a vision to build a sustainable world with clean energy for everyone.

"It's my passion to bring renewable energy to the world," Pepper added.

He was employed by the University of California for 36 years and worked as a farm advisor, 4-H advisor, then later as an agricultural researcher and educator. In his retirement he owned his own research and consulting company, which he enjoyed very much. In his spare time, he loved gardening and wood working.



He was a loving and devoted husband to Carol Ann Weir,

they shared a wonderful journey as a couple, as best friends and partners in life. They would have shared 61 years of marriage this month, August, 25 2022.

Together they traveled to fifty-five countries, where he spoke in many of them about his agricultural research in cotton. He was known as the "Father of narrow row 30 inch cotton". His research in the conversion of cotton rows and harvesters from 40 inch rows to 30 inch rows was instrumental in establishing the 30 inch cotton culture, which transformed the agricultural industry. In this research he found that utilizing the 30 inch rows would increase the cotton yield, thereby increasing the financial gain for the farmers per crop. During his travels, he helped to establish utilizing 30 inch rows in their agricultural practices. He was also instrumental in research on the use of Pix growth regulator on cotton and potassium deficiency symptoms in cotton.

He taught for 20 years at Merced College in the agricultural department and served on the California Cotton Alliance Board, which he enjoyed very much. He was also a member of the California Association Farm Advisors and Specialists from 1980-1991. He conducted research in cotton and many different crops and made a big difference in the agricultural world at large.

He is survived by his loving wife Carol Weir, his son Daniel Louis Weir and daughter-in-law Teresa, and his daughter Deborah Leanne Weir. Grandchildren; Cristi Weir, Vanicia Wilhelm, Alex Myers, Tisneem, Zaynib, Humzah, Rowtha, Omar and their spouses. Including many great-grandchildren and his three nieces. He is preceded in death by his parents, one grandson, one great grandson and two sisters, Louise Mayo and Laverne Fisher.
