Los Banos Council to interview three search firms for hiring permanent city manager

During their meeting on July 20, 2022, the Los Banos City Council voted to publicly interview three executive search firms to help find a permanent city manager to replace Josh Pinheiro who was terminated in June. District Councilwoman Deborah Lewis 4 dissented.

A Request for Proposal (RFP) was sent to eleven recruitment firms that specialize in public sector executive level recruitments. In response the City received three proposals from the following firms with their costs for the council to review:

- Koff & Associates (Berkeley, California): not to exceed \$25,000
- ProRecruiters (Tulsa, Oklahoma): \$20% of first-year salary
- Sectaris Partners (Merced, California): not to exceed \$22,000

Introducing the new owner of the Los Banos Enterprise

As of May 27, 2022, the Los Banos Enterprise is under the ownership of San Joaquin Valley native Michael Braa.

Born in 1963 to parents who worked in the banking industry, Braa grew up in the smaller ag towns near Los Banos and attended schools were

there were barely enough kids to fill a classroom. His Godparents owned a dairy farm where he spent some of his time.

"The news came to us through either the nightly news at 6 p.m. or the local newspaper," he said. "There were no cell phones, no computers, no social media companies. The community was neighbors first, followed by church, then town, and then the rest of the world. Now that has all been turned around."

After quitting high school early thinking education wasn't for him, two months to the day after his 17th birthday, Braa joined the Navy and served through three deployments

while the United States faced off against the only other world superpower in history.

Following four years of service, he had a change of heart and mindset and headed to college at U.C. Berkeley where he graduated in 1993 with a





Los Banos Councilman Jones announces run for re-election

Faria, LLamas, Mallonee, Tomas, not running, yet

Los Banos District 3 Councilman Brett Jones has announced he will be running for re-election to a second term. Filing opened on Monday July 18 for the November elections.

In a post on his official Facebook page, that day, he wrote:

"It's been a privilege representing

Los Banos District 3 these last 4 years. The time has come again for me to continue my public service and run again in my mission to help improve this little town we all call home. I'm current seeking nominations and your support is greatly appreciated. Please send me a direct message or call me on my cell and I would be more than happy to come to

He shared a graphic of the map of District 3 and a copy of his nomination papers for which he needed signatures of registered voters who live in the district.

When reached for additional comment about his re-election bid, Jones said, "I already have enough signatures to qualify and have an appointment set up for Thursday at the county elections office."

Asked what his major issues are he responded, "what we really need is commercial industry, from shopping amenities to jobs. We have a ton of homes. We need a number of revenue streams of sales and property taxes from businesses. So, commercial development is the key to bolster the economy. The number one thing is making it easier for businesses to come into town."

Rail/Mass Transit, Search and Rescue and the State Threat Assessment System.

In third place was Dos Palos native and Firebaugh resident, Republican Amanda Fleming, who works for her family's Ag & Industrial Supply Company, with 8,527 votes or 16.8% of the vote. In last place was another Fresno Councilmember, Democrat Mike Karbassi who represents District 1 and is part owner of his family's Persian rug business. He received 4,096



In Merced County, the race was much closer with Soria, also placing first, garnering 10,695 votes or 39.27% to Pazin's 10,302 votes or 37.83% of the vote. Fleming had 4,272 votes or 15.69% and Karbassi received 1,909 or 7.1% of the vote. There were a total of 57 write-in votes for just 0.21%.

12 for District 3 since the incumbent is running, again.

Asked on Wednesday, July 27 if he was running for re-election and if so, had he announced, yet District 2 Councilman Refugio LLamas responded, "Good afternoon. Thank you very reaching out. Nothing as of yet." Pressed further asking, "So, you haven't decided or just haven't announced, yet?" he did not respond.

A review on July 28 of the list of candidates for the November election on the Merced County Registrar of Voters website shows neither Llamas nor Faria had taken out their nomination papers, nor had City Clerk Lucy Mallonee or City Treasurer Kim Tomas. Jones pulled his required nomination papers on July 18, then filed them and paid the filing fee on July 21 to run for re-election.

Asked if she's running for re-election, Mallonee said, "I haven't really decided, yet. But I have until the 12th. I have time."

An effort to reach Faria and efforts to reach Tomas were unsuccessful prior to publication time.

Merced County's first 100 Day Challenge finds housing for homeless in Los Banos

Multi-agency effort By Mike Dunbar, Office of Assemblymember Adam Gray and Mike North, PIO, County of Merced

More than 150 Merced County children call motel rooms home. Another 41 people under age 24 live unsheltered in cars, under highway bridges or in tents along the roadside.

Living in such conditions leads to poor health, poor nutrition and poor grades for those in school. Some, as they get older, can be at higher risk of turning to crime or substance abuse. The human and financial costs of people living in these conditions are enormous, both for those experiencing it and for the community.

Merced County, its cities, several non-profits and many volunteers have committed to addressing the problem of child and youth homelessness through a second 100-Day Challenge, which began July 6.

The goal is to find housing for 100 children and young people and their families in 100 days.

The effort will concentrate on those living in temporary shelters with an emphasis on racial equity.


"Since 2020 we have seen a 170 percent increase in families experiencing homelessness," said Lloyd Pareira, Chairman of the Merced County Board of Super-

visors. "They are residing in motels being used as emergency shelters by the county. We believe by focusing on finding stable housing for at least 100 children and youth in the next 100 days, we can make a real difference for those kids and for our county"

Merced Mayor Matt Serratto, who chairs the city-county Continuum of Care, was encouraged by the number of agencies, volunteer groups and others involved including the Housing Authority, Merced County Office of Education, Assemblymember Adam Gray's office, Healthy House, Turning Point Community Programs, Merced Rescue Mission, the Community Action Agency, Worknet, Behavioral Health and Recovery Services



and the Human Services Agency.

"This is exactly the kind of effort we need to address the often-complex needs of families experiencing homelessness," said Serratto.

In May, Merced County completed its first 100-Day Challenge - a state-sponsored program assisting local residents develop unique solutions to homelessness K E R C E D

within their communities. Working with RE!NSTITUTE coaches, local teams were asked to define the problems, set goals and then implement solutions in their specific communities. RE!N-STITUTE works with four counties at a time, and Merced's cohort

included San Bernardino, Santa Cruz and Sacramento.

Helped Homeless Find Housing in Los Banos

Merced County's goal was to find permanent housing for 20 individuals who had been living in Los Banos homeless encampments. The Challenge team - which included county staff, Los Banos public safety, members of Assemblymember Gray's staff and many others visited two large encampments, compiling profiles of each of the 151 people living in them. Other Challenge team members described the problem to community organizations while others searched for suitable, affordable housing.

At the end of the 100 days, Merced County had reached its goal, finding housing for 13 percent of Los Banos' homeless population. The team also helped

65 more adults enter a pathway to safe and stable housing by finding them emergency shelter or connecting them with family or service providers. The Challenge was judged an enormous success.

"Once again, when given the opportunity and resources, Valley folks proved that their hearts are as strong as their arms," said Gray, who has helped find state

funding for homelessness programs in both Merced and Stanislaus counties and annually participates in the Point-in-Time census. "It wasn't just finding homes for those individuals, the Challenge team helped them find hope and direction."

Merced County Superintendent of Schools

Steve Tietjen was clear on the importance of meeting the Challenge.

"Succeeding in school is hard enough for most kids," said Tietjen. "It's hard to imagine how much more difficult that is if you're worried about where you'll be sleeping that night or what you're going to have to eat. By helping these kids and their families, we can make real difference."

Making a difference is the real goal, said Gray: "Our next Challenge – getting young people into stable living situations helps our communities now and far into the future."

In this new journey, Merced will join the communities of Santa Barbara, Eureka, Lake County, Los Angeles, Richmond and Santa Cruz.

Los Banos Weekly Crime Report for July 3-9, eight arrested

19-year-old loses his freedom on Independence Day for shoplifting, drug possession, resisting arrest

According to the Los Banos Police Department's website seven arrests were made, and the following police calls



for service occurred in the city from Sunday through Saturday, July 3-9, 2022. There w ere r eports o f s ix stolen vehicles; seven assaults - six for domestic violence; three burglaries – one commercial and two vehicles; 60 calls for disturbing the peace many for loud parties (people, turn the music down!); 16 reports of thefts i ncluding four from vehicles and two for shoplifting; a nd s ix r eports o f v andalism including two to vehicles and one for graffiti/ tagging.

Arrests

A total of eight arrests were made in Los Banos during the week.

On Monday, July 4 at 10:59 a.m., David Gaona Medina, age 19, was arrested in the 2000 block of Rail Trail for petty theft – shoplifting.

Commander Ray Reyna provided additional details about the arrest. "On July 4th at approximately 9:54 a.m., Officer Cody May and Officer Juan Soriano responded to the ARCO gas station on E. Pacheco Blvd. regarding The clerk theft. а



reported a male suspect, later identified as Medina, entered the store and stole several food items from the business without paying.

Officers located the male suspect a short time later on S. Place Road and attempted to stop him. Medina attempted to run from the officers on foot, but he was caught after a short chase. Medina still had some of the stolen property in his possession and he was also in possession of suspected methamphetamine. Medina was booked into the LBPD jail for petty theft, resisting arrest and possession of a controlled substance."

On Wednesday, July 6 at 12:22 p.m., 29-year-old Melvin Swepson was arrested in the 1300 Block of San Luis Street for a misdemeanor parole violation.

Also, on July 6 at 10:32 p.m., 31-year-old Lawrence Norbert Arechiga was arrested at 4th and J Streets for DUI.

Three arrests were made on Thursday, July 7. First, at 12:58 a.m., 40-year-old Joseph Paul Amaro was arrested in the 1700 block of E. Pacheco Blvd. on multiple charges including: giving false ID to police, false pretenses/ swindle/ confidence game, battery of a spouse/ ex-spouse/ date/ etc. and two outstanding warrants, one for a felony, the other for a misdemeanor. According to localcrimenews.com, Amaro was also arrested in January 2014 by the Stanislaus County Sheriff's Department for inflicting corporal injury on a spouse/cohabitant, then again, in May 2021 for possession of a controlled substance and drug paraphernalia.

Joshua Matthew Evans, age 25, was also arrested on July 7 at 10:15 a.m. by Merced Police for first degree robbery. According to localcrimenews. com, he has a history of arrests dating back to 2016, including by the Merced County Sheriff's Department for street terrorism, vandalism of \$5,000 or more and possession of drug paraphernalia; three times in 2017 by Antioch Police for possession of a controlled substance, receiving stolen property motor vehicle and auto theft, as well as robbery and assault with a deadly weapon or assault with force likely to cause great bodily harm; five times in 2018 by the Merced County Sheriff's Department and Merced Police for driving without a license, possession of drug paraphernalia, possession of a controlled substance, auto theft and inflicting corporal injury on a spouse/cohabitant; in 2019 by the Merced County Sheriff's Department on a warrant/ hold; and twice in 2021, once by the Sheriff's County San Mateo Department for possession of a

controlled substance, contempt of court: disobeying a court order/ process, conspiracy to commit a crime, carrying a concealed dirk or dagger and shoplifting; then by Merced Police for disobeying a domestic relations court order, driving without a license, and evasion - wanton disregard for safety.

The t hird p erson a rrested i n L os Banos on July 7 was 40-year-old Antonio Jose Contreras at 3:35 p.m. at Home Depot on a bench warrant for a failure to appear on a misdemeanor charge.

On Friday, July 8 at 11:16 p.m. 32-year-old Crystal Monique Ramirez was arrested in the 100 block of N. Santa Rita Street for an outside misdemeanor warrant.

Finally, on Saturday, July 9 at 2:13 a.m., 53-year-old Raul Barros Aguirre was arrested in the 100 block of W. Pacheco Blvd. for DUI and an outside misdemeanor warrant.

Police arrest Los Banos man for domestic violence, gun charges

On July 10, 2022 the Los Banos Police Department responded to the 1600 Block of Foxmeadow Court to investigate a report of domestic violence. During the course of the investigation, officers learned the victim's husband, 44-year-old Thomas Michael Komarek of Los Banos, assaulted her and threatened her with a shotgun. The victim also reported Komarek took her cellular phone as she was attempting to call 9-1-1 for help.

An arrest warrant was obtained through the Merced County Superior Court and on July 14, Sergeant Jesus Parras and a Federal Agent spotted Komarek walking in the area of San Luis and Jeffery Road. As the officers attempted to arrest Komarek, he ran from the area but was caught and placed under arrest a short distance away.

Officers served a search warrant at Komarek's residence and located a loaded shotgun. Komarek is currently the subject of a court restraining order and therefore prohibited from owning or possessing a firearm. Komarek was booked into the Los Banos Police Department Jail, pending \$50,000.00 bail, charged with domestic violence, brandishing a firearm, preventing the use of 911, violation of a domestic violence restraining order, resisting arrest and prohibited person in possession of a firearm.

According to recentlybooked.com he also faces charges of resisting arrest.

According to localcrimenews.com, Komarek has a history of arrests over the past five years all by the Merced County Sheriff's Department for drugs, public intoxication, violating a court order on domestic violence charges and vandalism of \$5,000 or more.

In 2011 he started the Atlantis Detective Agency in Fresno and in 2018 changed the name to Atlantis Private Investigations which owns and operates, today. According to the city staff report, the council could either direct staff to schedule interviews (either at an adjourned meeting, special meeting or the next regular meeting) with all of the three recruiting firms or in the alternative, the city council could select a preferred group of less than all three to be interviewed. Or the council could select one of the firms based upon the proposals received without conducting interviews and direct the interim city manager to enter into a professional services agreement with the selected firm.

"The only one that fit the criteria... would be the agency out of Berkeley," said Lewis. "They have given us a list of their successful recruitment.

of \$5,000 or more, trespassing and begin intoxicated in public.

On a motion by District 3 Councilman Brett Jones with a seconded by District 2 Councilman Kenneth Lambert, the council voted 4-1, with Lewis opposed, to interview all three firms at a future council meeting, preferably the next regular meeting and if necessary, by Zoom to accommodate the out-of-state firm.

Funds are currently not budgeted for this expense; therefore, staff will continue to analyze the fiscal impact and prepare a budget adjustment at a later date, if needed.

Herrera Ibarra was previously arrested by MCSD on April 30 for disturbing the peace by fighting. Herrera Ibarra was also arrested by MCSD in April 2021 for child endangerment and DUI. He was also arrested by MCSD in Sept. 2020 on another DUI.

At 9:28 a.m. 47-year-old Thomas Lee Marquez was arrested in the 100 block of N. Santa Rita Street for petty theft - shoplifting. 
Our city is growing and needs a major medical player.
